

CCR Skills Summit

On Thursday 21st September, the Cardiff Capitol Region (CCR) Employment and Skills board hosted their Skills Summit at the Novotel in Cardiff. The event provided an opportunity for government, industry and educators to explore the detail within the newly launched 2017 Employment and Skills Plan and debate current and future challenges/opportunities.

The event also provided a platform for a number of ESF projects to promote their work across the CCR region:

The keynote speaker in the morning was Julie James AM, Minister for Skills and Science who focused on the importance of skills to the region and to Welsh Government policy. She underlined Welsh Government's commitment to ensuring the skills offer in Wales was receptive to both employer and regional needs.

After lunch, Cllr Debbie Wilcox, the CCR's Joint Cabinet Lead for Employment and Skills and Leader of the WLGA, addressed the assembly on the theme of positive and long term collaborative working across the ten local authorities in the region.

A message from the Valleys Taskforce

We spent six months talking and listening to the people who live and work in the valleys about what they want to see in their local communities, now, and in the future. It is these discussions that have helped shape "<u>Our Valleys, Our Future</u>" and the priorities going forward.

The people of the Valleys told us that good quality jobs were needed as well as the skills to do them. We also heard from businesses that they need support from us in order to grow and be able to offer employment and training to local people. We are looking to target investment to deliver high-quality employment sites and premises across the valleys. We also want to make sure that when procuring contracts, we get the most for the Welsh pound.

We heard that there are some good public services in the valleys but they're not always as joined up as they could be. Affordable, frequent and accessible public transport was a key issue raised. We want to better serve the needs of local businesses and communities by taking full advantage of the development of the South Wales Metro and other transport developments to meet these needs.

We want to make more of the Valleys' natural environment; its culture and heritage, so that they are enjoyed more widely, both by local people and tourists. We want to improve personal wellbeing and new approaches to mental and physical health. We've agreed to develop the concept of a Valleys Landscape Park. We want to promote the outdoor activities we have in the valleys for the valleys communities and beyond.



The people of the valleys have helped identify what we need to focus on and why. We're continuing to engage with those that have already been part of this journey and invite others to join us.

Community Facilities Programme funding

The <u>Community Facilities Programme</u> is a capital grant scheme for improving community facilities. There are grants are available at two levels:

- small grants of between £5000 and £25000
- larger grants of between £25000 and £250000.

The Programme is open to community and voluntary sector organisations, including social enterprises. The aim of the programme is to

increase opportunities and develop resilient communities and engagement and partnership working will be key themes to cover in any application.

Delivery partners can come from the public, private or third sector and whilst priority will be given to applications from former Communities First cluster areas, applications from other areas are welcome.

The closing date for applications is 31st March 2018 but groups can apply at any time before then.

RDP funding windows

There are a couple of Rural Development Plan (RDP) funding opportunities available this quarter.

The Co-operation and Supply Chain

<u>Development</u> Scheme funds a variety of cooperation activities for new products, practices, processes and technologies across the agriculture, food and forestry sectors:

- small businesses working together to share production facilities and resources
- short supply chains and local markets including promotion activities in a local context
- pilot projects where the information is made publicly available and widely disseminated.

The window opens on the 18th October and closes on the 20th December.

The Rural Community Development Fund

window opened on the 10th August and offers grants which are primarily aimed at community-based organisations. For example:

- drawing up of community / village development plans
- investments in small scale infrastructure including renewable energy generation and energy saving actions
- investments in ICT including broadband
- improving access to services investments and studies for the maintenance, restoration and upgrading of the cultural and natural heritage
- Investments in the relocation of activities and conversion of buildings with a view to improving quality of life or increasing environmental performance

Brexit update

The Welsh Government has published a series of Brexit policy papers, building on their White Paper <u>Securing Wales' Future</u> that was published in January this year. To date, these include **Brexit and Devolution** (published 15 June) and more recently <u>Brexit and Fair</u> <u>Movement of People</u> (7 September).

Future papers to be published cover the areas of:

- 1. Trade
- 2. Agriculture and Food
- 3. Regional Investments

Later this Autumn, the Welsh Government is expected to launch a consultation on the future of regional investment in Wales following the publication of its third policy paper sitting underneath **Securing Wales' Future** which calls for replacement funding in full and for devolved competences to be fully respected. Publication of the paper will also mark the beginning of some detailed discussions with partners and stakeholders across Wales.

The UK Government is also expected to launch its own formal consultation on its proposed replacement for EU Structural Funds, known as the UK Shared Prosperity Fund, around the UK Autumn Statement (22nd of November). Its aim is to complete the planning by June 2018 and launch the new fund in 2019.

Within the National Assembly for Wales (NAfW), the Constitutional and Legislative Affairs and External Affairs and Additional Legislation Committees recently had a joint <u>consultation</u> open on the implications of the EU (Withdrawal) Bill for Wales. They also hosted a stakeholder training session on the bill (13th September) and an event for key stakeholders and experts (18th September) to discuss the potential implications of The EU (Withdrawal) Bill for Wales.

The third round of Brexit negotiations took place in Brussels between 28th and 31st August. There were a number of papers published by both side during the summer. Notably, the UK has published papers on <u>new</u> customs proposals (15th Aug), <u>NI and Ireland</u> (16th August) and <u>goods on the market</u> (21st August). Michel Barnier, from the EU, published a raft of new <u>EU Brexit papers</u> on 7th September. They include Guiding Principles for the Dialogue on Ireland and Northern Ireland and papers on customs matters; data; public procurement; and intellectual property. The next round of negotiations will take place during the last week of September.

On 11th September, the EU Withdrawal Bill passed its first parliamentary test when MPs backed it by 326 votes to 290 following the second reading of the bill. The UK Government introduced the <u>Bill</u> to Parliament on July 13th. A key part of the UK Government's Brexit strategy, the bill will convert all existing EU laws into UK law and ensure EU law will no longer apply in the UK. First Minister of Wales, Carwyn Jones, and Nicola Sturgeon, First Minister of Scotland, responded to the Bill with a joint <u>statement</u> and on the 12th of September, the Welsh



Government published a <u>formal challenge</u> to the UK Government's EU (Withdrawal) Bill in the form of a Legislative Consent Memorandum (LCM) laid before the National Assembly for Wales. It is possible that the Welsh Government will also bring forward a "Continuity Bill" to protect the current devolution settlement. As this would need to be passed prior to the UK EU Withdrawal Bill, it would need to go through emergency procedure this autumn. The Bill's Committee stage will take place when MPs return to parliament after their party conferences.
